Dear Students,

We are pleased to enclose the second half of your scholarship for the 2014-2015 academic year to be used for Spring 2015 semester tuition, fees and expenses. Please keep in mind that all students are required to maintain full-time status (that is, earn a minimum 12 credit hours per semester for a minimum of 24 credits per academic year) and a minimum cumulative grade point average (GPA) of at least 1.5 each semester and a minimum of 2.75 (3.0 for Richardson and Jaffe Scholars) for an academic year. If you received your award prior to 2013, the minimum cumulative grade point average for the academic year is a minimum of 2.5. Failure to comply will result in probationary status and possible forfeiture of future scholarship funding.

As a reminder, if you are eligible to receive funds for the 2015-2016 academic year, it is your responsibility to renew your FAFSA and submit your SAR to us (it is suggested that you renew your FAFSA by February 2, 2015). Before we can evaluate your financial need and eligibility for the 2015-2016 academic year, we will need to receive the following documents from you:

1. A copy of your Student Aid Report (SAR) for the 2015-2016 academic year.
2. A copy of your financial aid award letter (or website printout) from your college or university for the 2015-2016 academic year
3. A copy of your grades or transcript from the Spring 2015 semester.
4. If you are taking summer classes, you will need to submit your Summer 2015 class schedule
5. Submit Fall 2015 class schedule

Items #1-4 listed above must be received in our office no later than JULY 1, 2015

Note: Failure to provide these items by this deadline will automatically result in forfeiture of the award for the upcoming semester and will result in forfeiture of all remaining award payments if you do not provide the required information by September 14, 2015.

Please keep this letter as NO REMINDER NOTICE WILL BE SENT. These requirements and deadlines are also available at our website www.SFIndianRiver.org. If we determine that you are eligible for funding for the 2015-2016 year, your check will be available after Aug. 3, 2015. At that time, you will also need to submit your Fall 2015 class schedule to receive your check, if you have not previously submitted it. Check pick up times will be daily 10:00 AM to 2:00 PM.

Please sign and return the copy of this letter attached hereto, and return to this office within 10 days of receiving it. PLEASE KEEP ONE COPY FOR YOUR FILES.
